Certificate of Insurance to be attached evidencing that the applicant is insured against all hazards and risks of loss which may arise from or out of the performance of the work, whether such performance be by himself, his subcontractor or anyone directly or indirectly employed by him and shall include protection against liability arising from completed operations. This insurance should be written in comprehensive form and the liability limits shall not be less than the following:

1. Bodily injury \$100,000.00 each person \$300,000.00 each occurrence
2. Property damage \$50,000 each occurrence
3. Certificate of insurance shall contain a provision that before a policy covered thereby shall be changed, canceled or not renewed, 10 day prior written notice shall be given.

Three sets of plans and specifications, a traffic control plan in accordance with the Manual on Uniform Traffic Control Devices and/or a detour plan must be submitted or a request for a waiver of the traffic control plan with sufficient documentation for the request of waiver.
