RULES CONCERNING REQUEST OF USE OF VILLAGE PROPERTY/FACILITIES

ALL REQUESTS for Use of Facilities must have prior approval by the Village Board of Trustees. Village Board meetings are held on the 1st and 3rd Mondays of each month at 7:00pm in Village Hall, 303 Main Street.

NOTE: EVENTS AT ROE PARK SHOULD HAVE BEEN CLEARED THROUGH THE TOWN OF HIGHLANDS RECREATION DEPARTMENT PRIOR TO COMING BEFORE THE VILLAGE BOARD. PLEASE ENSURE THAT THE BOTTOM SECTION ON PAGE 2 OF THE EVENT FORM IS SIGNED BY THE DIRECTOR OF RECREATION, INDICATING THERE ARE NO CONFLICTS WITH THE REQUESTED DATE(S).

Any person or group/organization must provide a certificate of insurance **naming the Village as additional insured**. Certificate must include date and type of event and be submitted with completed application. Any person or group/organization will also be required to sign a license agreement prior to the event.

RULES CONCERNING USE OF ROE PARK

1. No bouncy house or other inflatables permitted regardless of insurance indemnification.
2. Any person or group/organization granted a license to use the facilities must adhere to all traffic and parking regulations surrounding the area. **No parking is allowed within the fenced-in perimeter of Roe Park.**
3. Any person or group/organization granted a license to use Roe Park Field and/or Little League Field and dugouts must **ensure the area is cleaned up of trash and garbage at the conclusion of the event.**
4. Any person or group/organization granted use of the Pavilion must adhere to the following:
 - NO** grills, cooking device, or fires allowed under the Pavilion
 - NO** alcoholic beverages
 - NO** skateboarding or bicycle riding under the Pavilion
 - NO** loud music
 - NO** standing or climbing on picnic tables
 - NO** unleashed dogs on field, in playground area, or Pavilion area
 - NO** smoking
5. Park Closes at Dusk.
