2. Proof of current workmen's compensation & comprehensive general liability insurance stating City of Humble as the certificate holder. (not less than \$250,000.00 per occurrence for bodily injury and \$100,000.00 per occurrence for property damage)
3. Copy of State issued Masters or equivalent License (when applicable).
4. Copy of state issued Drivers License.
5. \$100 registration fee for contractor (Company/Person/License Holder) **Registration Valid For One Calendar Year. (Jan 1st thru Dec 31st) Must renew Annually**

Each of these items must be provided IN PERSON, by the License Holder if applicable without exception, approved, and entered into our records before any work may be permitted or commenced in the City of Humble. (The license holder MUST register the Company)
