

Solicitor / Peddler Permit Information Sheet

Definition of Solicitor: Any person who, not having been invited by another (except on premises where that person is employed or resides), takes or attempts to take orders for the sale of goods, merchandise, wares, or other personal property of any nature for future delivery, or for services performed in the future. A solicitor shall also include any person who distributes handbills and flyers advertising a commercial event or service. (Village Code 3-12-1)

Definition of Peddler: Any person who, not having been invited by another, carries or transports goods, wares, merchandise or personal property of any nature and offers the same for sale (except on premises where that person is employed or resides). A peddler shall also include any person who solicits orders and, as a separate transaction, makes a subsequent delivery to a purchaser. (Village Code: 3-12-1)

Process for Solicitor's Permit:

- Fill out the Application for Solicitation and bring it to the Manteno Police Station (269 N. Main Street)
- Pay a \$50.00 fingerprint and criminal background investigation fee at the time the application is turned in
- There may be up to a 72 hour waiting period for the criminal background check
- If the background check is clear and there is no other cause to deny approval of the application, you will be contacted to return to the Police Station to complete the process
- Pay \$50.00 Village of Manteno Solicitor's Permit Fee
- Get issued a Solicitor's ID
 - good for 30 days
 - must be worn at all times while soliciting
 - Not transferable to any other individuals

Permit Expiration: All permits shall show the days during which the solicitor or peddler is authorized to conduct his activities. The Solicitor's Permit will not be valid outside of those dates.

Permitted Hours: Monday – Saturday: 9:00 a.m. – 9:00 p.m.
Sunday: 12:00 p.m. – 9:00 p.m.

It is unlawful to enter upon any private premises which has a sign bearing "No Peddlers" or "No Solicitors". This included the entirety of the four 55 year or older modular home (mobile home) communities that are considered private property.

- Maple Valley on N. Birch Street
- Maple Crest Manor on N. Birch Street
- Maple Ridge on E. Third Street
- Oak Ridge on S. Sycamore Road

If requested to leave a premise, the solicitor or peddler must do so immediately and peacefully.
