1. The group \_\_\_\_\_ agrees to defend, indemnify, and hold harmless the Village of Lakemore from any claim, demand, suit, low, cost of expense, or any damage which may be asserted, claimed, or recovered against or from the Village of Lakemore by reason of any damage to property, personal injury, or bodily injury, including death, sustained by any person whomsoever and which damage, injury, or death, arises out of or is incident to or in any way connected with the performance of this contract, and regardless of which claim, demand, damage, loss, cost of expense is caused in whole or in part by the negligence of the renting group, the Village of Lakemore, or by third parties, or by the agents, servants, employees or factors of any of them.
2. That said group agrees to clean, lock, and police said park following usage thereof and to leave such facility in the same condition as it was immediately prior to their usage. In the event that said group fails to clean, police such facility after usage, or contact emergency number of any emergency conditions or necessary repairs, said group, through its authorized representative, agrees that it shall pay and be liable for any and all cleaning and repair expenses incurred by the Village of Lakemore as a result of said group's usage of such facility during the time period set forth above. Said group understands the deposit of \$50 will only be returned if these provisions are met.
3. That said group agrees to NOT USE any staples, nails, or other temporary fastening devices on ANY areas of the Village of Lakemore's property. Use of such items will result in denial of any future rental privileges and loss of deposit. Any permanent damage could result in legal repercussions.
