AS BUILT: If plans change, please submit a new set of as-built drawings to the city for our records.

FOR MODULAR HOMES: A copy of the approved decal/insignia as required by the Texas Department of Licensing and Regulation must be provided.

FOR MANUFACTURED HOMES: Only HUD-code Manufactured Homes are permitted within the city limits. Installation of HUD-Code Manufactured Homes are restricted to their respective zones. A copy of the HUD certificate must be included with the permit.

FLOODPLAIN INFORMATION

The flood boundary maps and other flood data used by the city in evaluating flood hazards to proposed development are considered reasonable and accurate for regulatory purposes. They are based on the best available scientific and engineering data. On rare occasions, greater floods can and will occur, and man-made or natural causes may increase flood heights. Construction standards required by the City of Sour Lake Flood Plain Management Regulations are the minimum standards deemed necessary to minimize or eliminate flood damage. Still, reliance on these minimum standards shall not create liability on the part of the City of Sour Lake, City Manager, or any other officer or employee of the City of Sour Lake in the event flooding or flood damage occurs.
