CONDITIONS OF PERMIT

1. Responses to questions on this application must be **PRINTED** in ink, or electronically filled in, and must be **LEGIBLE. ANY APPLICATION THAT IS NOT LEGIBLE WILL NOT BE ACCEPTED.**
2. Application approval is subject to a background investigation conducted by the Delta Police Department.
3. Permits shall not be valid beyond the expiration date specified and cannot be assigned or transferred to anyone other than the applicant.
4. Permit must be displayed upon request of any officer of the Delta Police Department or any citizen of the Village of Delta.
5. The background investigation will be completed within five (5) working days of receipt of this application.
6. A **non-refundable** filing fee of fifty dollars (\$50) must accompany this application to cover the cost of investigation of the facts stated on the application.

I have received a copy of the Delta Village Ordinance section 717, which governs the licensing procedures and penalties regulating peddlers and solicitors within the Village of Delta, Ohio.

I further state that I have read, understand, and accept the conditions of this ordinance.

I also swear that all the information given in this application is true and correct to the best of my knowledge.
