Checks shall be made to the City of Buellton. All applicants must be at least 18 years of age and must provide a copy of a utility bill or sewer/water bill showing residency in the City of Buellton.*

*All rental agreements are for a period of 6 months. At that time the applicant must return the key and will receive the \$25 deposit. If there is not a waiting list for bike locker rental and an extension of the agreement is desired, the key can be kept by the applicant and the \$25 deposit held by the City for another 6 month period.*

*Signing of the rental agreement provides for inspection of the locker by the City of Buellton and/or Law Enforcement officials as deemed necessary and limits liability. The City of Buellton reserves the right to inspect lockers with or without notice to renter. The City of Buellton retains the right to deny usage of the Park and Ride bike lockers to any individual.*

*The rental agreement entitles the applicant to store one bicycle and related bicycle equipment, such as a helmet or a pump in the designated locker for the 6 month period or until cancellation or termination of the rental agreement. If items other than a bicycle or bicycle related equipment are stored in the locker, this agreement will be terminated. Upon such termination, the City of Buellton has the right to empty the locker of any property stored therein. Any applicant whose agreement has been terminated is prohibited from renting a bicycle locker for a period of one year.*

*The applicant agrees by signing the rental agreement that the City of Buellton has the right to ensure only one bicycle and bicycle related equipment is stored in the locker.*

*The City of Buellton is not responsible for fire, theft, loss or damage to the bicycle or any other items left in the locker, and are not liable for any injury, loss or damage arising from the use of any assigned lockers. It is the renter's responsibility to ensure the locker is secure at all times and to report any damage or malfunctioning of the assigned locker to the City of Buellton. If the locker becomes unusable due to circumstances not involving the renter, the renter will be allowed to use another locker if one is available. In the event of key loss during the rental period, the renter will be charged for a lock change and new key.*
