I agree to install gas heating system requested, as per the provisions stated in this application and to North Carolina Code Residential Code or North Carolina Building Code - Commercial and comply with Volume I-A, Section 309.6, Service Utilities.

Agreement For Temporary Gas Heat By Responsible Agent

I, _____ (General Contractor), as the Responsible Agent authorized to control and supervise construction activities at the building described above, hereby apply for permission to utilize a portion of the building's permanent gas heating system for temporary gas heat solely for the purpose(s) as stated above. For this consideration, I, by this declaration under seal and signed, do hereby promise, covenant, and agree as follows:

That this application is specifically limited to utilizing natural or L.P. gas systems for the intended use and duration of time as stated above.

That my qualification as Responsible Agent and the necessity for temporary gas heat shall be at the sole discretion of the City of Rockingham Inspection Department, and shall not be granted solely for convenience.

That I agree to make payment of all applicable fees for temporary gas heat as determined by the City of Rockingham Inspection Department prior to their inspection and authorization of utility company gas hook-up.

That I agree to obtain written and signed approval (on this application form) from the mechanical contractor stating the designation, of the gas heat, and suitability of each unit to be utilized for temporary gas heat. I also agree to obtain similar written and signed approval (on this application form) from any other contractor requiring temporary gas heat to enable their work to be completed where adequate temperature must be maintained to facilitate the installation of certain materials or finished in accordance with the manufacturer's instructions.

That I, as the Responsible Agent and applicant for temporary gas heat, shall neither hold the City of Rockingham, State of North Carolina, nor its governing officials, nor City Code Enforcement Officials, responsible for any damages or injuries to any persons or property which occurs or may occur from failure to safely maintain the activated gas heating system or that portion of the building containing the system in a secured and locked manner or under constant supervision to exclude unauthorized personnel, or from our failure to alert personnel working in the vicinity of the activated gas heating system to its presence, or as a result of any connection or disconnection of the temporary gas heat by the gas utility company or others.
