GARAGE PERMIT

Garage Requirements

- Accessory building must be a minimum of 5' from property line and 10' from principal building
- The garage, when combined with the area of other structures in the rear yard, shall not exceed 40% of required rear yard area
- A garage cannot exceed 18 feet in height
- No property shall be permitted to have an accessory structure without a principal building. No property shall be permitted to have more than two accessory structures
- Must be constructed of wood, masonry, or vinyl only. NO metal buildings, NO pole barns
- Highest point of shed must be at least 8 feet below all overhead electrical wires
- Existing grade should not be altered
- Excavated spoils will need to be removed from site
- No construction equipment/materials shall be deposited or stored within the City Right-of-Way
- Extreme care is to be taken to protect the existing utilities, pavement, curbs, and sidewalks
- Pavement, curb, and sidewalk should be ramped or planked to avoid damage
- If any portion of garage is in a flood zone, engineering approval is necessary
- If there is a septic field on the property, approval from the Will County Health Department is required

Inspections Required

- Pre-pour concrete
- Underground electric or trench (if applicable)
- Rough framing
- Rough electrical
- Final garage
- Underground electric (if applicable), rough electric (if applicable), final electric (if applicable)
- Rough mechanical (if applicable), final mechanical (if applicable)

Permit Documents Required

- Building Permit Application
- Copy of Plat of Survey-Clearly marked and work area highlighted, dimensioned and indicating setbacks from the house (including any accessory structures) and lot lines
- A site plan showing the proposed garage location and any existing structures drawn to scale. You may utilize the county GIS mapping system and print a copy for the drawing. Must include setbacks from house and lot lines
- Brochure (if-premanufactured)
- A detailed drawing (if stick built) indicating the material list, concrete specifications, dimensions, framing details including electrical layout and mechanical layout if applicable and anchoring for the garage
- Garage Contract – a copy of the contract proposal from the contractor

Include the permit number, project address, your name and phone number and type of inspection you are requesting. Do not leave a voicemail for an inspection request. Please send the inspections email before 3:00 for next day inspections.
