FEES:

Soliciting (Door to Door) on behalf of a group or association, each and every five persons - \$150.00

Peddler - \$300.00

Transient merchant - \$750.00 for a period of six months

FINGERPRINTS/BACKGROUND INVESTIGATION REQUIRED OF APPLICANT AT YOUR OWN EXPENSE

PROHIBITED CONDUCT:

- A. To enter upon any premises & ring the doorbell upon or near any door, or create any sound in any other manner calculated to attract the attention of the occupant of such residence, for the purpose of securing an audience w/the occupant thereof and engage in soliciting
- B. Whether registered or not, to enter upon any premises and ring the doorbell upon or near any door of a residence located thereon, or rap or knock upon any door or create any sound in any other manner calculated to attract the attention of the occupant of such residence prior to 9AM or after 9PM for political candidates or organizations and after sundown for all other solicitors of any weekday or Saturday or at any time on a Sunday or on a state or national holiday.
- C. Falsely represent, directly or by implication, that the information is being solicited on behalf of a governmental organization
- D. Solicitation by a charitable organization shall be for charitable purpose only
- E. Each person soliciting charitable contributions on behalf of an organization shall be at least 18 years of age
- F. Station, place, set up or maintain goods, wares or merchandise on any sidewalk
- G. Engage in conduct which shall:
 - a. Substantially restrict, obstruct, interfere with or impede the pedestrian's right of way; it is presumed that the right of way is substantially restricted where the unobstructed area available to a pedestrian is less than six feet
 - b. Substantially restrict, obstruct, interfere with or impede the ingress/egress from the abutting property
 - c. Create a condition which endangers the safety or health of any person
 - d. Increase traffic congestion or cause or increase traffic delay or hazards
 - e. Cause or constitute a danger to life, health or property; nor shall any peddler leave any location without first picking up, removing and disposing of any trash or refuse, whether resulting from himself or customers, without regard to whether or not an item was sold to said customers
- H. Use any vehicle which, when fully loaded with merchandise, cannot be easily moved and maintained under control by the licensee, his employee or attendants
- I. Leave any merchandise or other property unattended at any time or store, place or leave the same overnight on any sidewalk or public way within the borough
- J. Engage in the business of selling between 9PM and 9AM
- K. Engage in the business of peddling within 10 feet of any location where the curb has been depressed to facilitate pedestrian or vehicle movement
- L. Engage in business of peddling on any sidewalk or along any street which has been designated as a bus stop.
- M. Station, place, setup or maintain a cart or goods against any display windows of fixed location businesses, nor shall they be within 20 feet from an entranceway to any store, theater, library, school, sports arena or other places of public assembly
- N. Place a vehicle or cart or conduct a general peddling business at a location in the street where stopping, standing or parking is prohibited
- O. Act in such a manner as to restrict the continued maintenance of a clear passageway for vehicles
- P. Sell or attempt to sell any good or service from private property without the consent of the owner – LETTER MUST BE PROVIDED
- Q. Operate in any congested area where operations might impede or inconvenience the public. The judgement of a police officer shall be deemed conclusive as to whether the area is congested or the public impeded or inconvenienced.
