PROCEDURES FOR HAWKERS- PEDDLER & SOLICITORS LICENSE

Chapter 274 Section A347-1

The following are needed to apply for a license:

- ☐ Completed Application
 - Village Attorney Approved
 - Village Manager Approved
 - Clerk-Treasurer Approved
- ☐ Non-Residents Only: Surety Bond in the amount of \$1,000 (bond or cash). Newspapers and Books are exempt.
- ☐ Proof of insurance certificate naming the Village of Mamaroneck, its officers, agents and employees. As additionally insured with the following limits: for personal injury, \$1,000,000 per individual and \$1,000,000 per occurrence; and for property damage, \$1,000,000 per individual and \$1,000,000 per occurrence, effective for the duration of the license, as follows:

- ☐ Annual License Fee:
Resident: \$210.00
Non-Resident: \$510.00
- ☐ Two Passport Sized Photos (1" x 1") taken not more than sixty (60) days prior to submitting application.
- ☐ Non-Residents Only: Character Reference Letter
- ☐ Certificate from County Department of Health if food is being sold.
- ☐ Must be given a copy of this Chapter of the Code and obey the rules of this license.

Notes: Veterans must submit a Veteran's Exempt Certificate obtained from Westchester County to be exempt from license fees. Books and Newspapers are exempt from paying the license fee.
