You are required to register with Central Collection Agency (CCA) for tax filings/payments, you are required to file and pay local income tax for **1.5%** on profits and/or net income, you are required to pay according to law all amounts withheld from employees for taxes, you are required to file and pay all taxes per Federal, State, and Local laws, and you are required to update any business license application information as it changes.

Under penalty of perjury, I hereby certify that all of the information contained herein is true and correct to the best of my knowledge. Further, I hereby declare and affirm that I will:

- 1) Maintain adequate commercial or residential refuse collection on the premises or in support of commercial activity on the premise and maintain compliance of Chapter 951 regulating Garbage & Refuse;
- 2) Comply with Ohio State Fire Code as implemented through the State Fire Marshall's Office and implemented and enforced by the Geneva-on-the-Lake Fire Department through the Geneva-on-the-Lake Codified Ordinances Part Fifteen-Fire Prevention-Chapter 1501 and other applicable fire safety regulations;
- 3) Comply with the State of Ohio sales tax laws and have proof of a vendor's license.
- 4) Comply with Geneva-on-the-Lake Zoning Code;
- 5) Provide proof of current liability insurance;
- 6) Comply with specialized or additional permit requirements from the State of Ohio, Ashtabula County, or other official certifying or regulating agency, including, but not limited to, food service permits, hotel/motel permits, liquor permits, amusement ride permits, health certificate, merchant mariner license, captains license and other information concerning the applicant or business as may be reasonable and proper, having regard to the nature of the license desired by issuing authority and deemed necessary.
