- Fasten any rope, wire, electrical attachment, sign, or other device to any such tree.
- Close or obstruct any open space provide about the base of any such tree to permit the access of air, water, or fertilizer to the roots of any such tree.
- Pile any building materials within six (6) feet of any such tree.

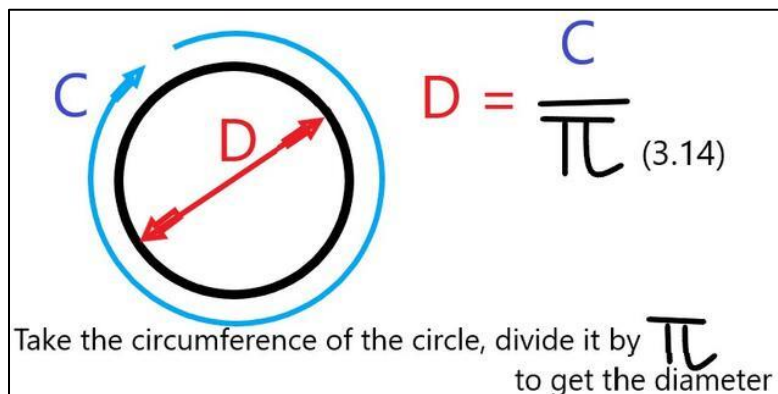

DBH stands for Diameter at Breast Height and is a standard method of measuring the diameter of a tree trunk. It is measured at a height of 4.5 feet (1.37 meters) above the ground.



- Permit application does not constitute approval; do not schedule tree removal until a permit has been approved by the Borough.
- A copy of the applicant's property survey (preferred) or a hand drawn map with the trees to be removed clearly located is required for this application to be considered.
- The submittal of a tree replacement plan may be required and is indicated below.

- No substitutions of replacement tree varieties permitted without prior Borough written approval.
- Approved permits are valid for twelve (12) months, beginning on the authorization date written below.
- ***The fee for processing this permit is \$35.00; for applications of six (6) or more trees, then the cost is \$7.00 per tree. SEPARATE CHECKS FOR FEE IN LIEU OF PLANTING.***
- For a subdivision or major site plan development application, the fee to be charged will be determined by the above formula or at a fee of \$1,300 per acre, whichever is greater.

REPLACEMENT SCHEDULE REQUIRED: Any person who removes one or more non-street tree(s), unless exempt, with a DBH of 6", unless otherwise provided, shall be subject to the requirements of the Tree Replacement Requirements Table. The species type and diversity of replacement trees shall be in accordance with a list of approved trees Attached hereto as Exhibit A and planting requirements kept on file in the Borough.

If the municipality determines that some or all required replacement trees cannot be planted on the property where the tree removal activity occurred, then the applicant shall pay a fee of per tree removed as follows:

OVER 36"	\$150.00
