

REQUEST FORM FOR DRIVING SAFETY COURSE

Holders of COMMERCIAL DRIVER'S LICENSE are **NOT** eligible for Driving Safety or Deferred Disposition

Under the laws of the State of Texas, you may request that one moving violation against you be dismissed by taking a driving safety course or motorcycle operator training course.

HOWEVER, YOU WILL LOSE THIS OPTION IF YOU DO NOT REQUEST IT IN PERSON OR IN WRITING ON OR BEFORE YOUR APPEARANCE DATE AS SHOWN ON YOUR CITATION.

NOTE: the Court DOES NOT accept a telephone call as an appearance

This option is available if you hold a valid Texas Driver License or permit, or are a member of the U. S. Armed Forces on active duty (or dependent of active duty military), and show proof of financial responsibility (insurance). This option IS NOT AVAILABLE if you are charged with speeding 25 mph or more above the posted limit, or speeding 95 mph or more in any zone; have used this option within the last year to dismiss a charge, or are charged for a violation occurring in a work zone with workers present. Driving safety is also NOT an option for Passing a School Bus, Accident involving damage to a vehicle, Fail to Stop and Render Aid, and any other serious traffic offense.

If you wish to use this option to have this violation dismissed, complete the request form below, and return it to the Court with the required items/information listed ON OR BEFORE your appearance date. Once your request has been received, the court will mail information needed to complete the course online, and to request your driving record (if required). You will receive an affidavit to sign and return to the Court if the driving record is not required. You may also complete the course in a traditional classroom setting (you will be required to locate a class in your area). The violation will be dismissed upon receipt of your driving record/affidavit and signed court copy of the completion certificate on or before the due date.

INCLUDE WITH THIS REQUEST:

Copy of your Texas Driver License/Permit or active duty/dependant military ID card

Copy of your valid insurance

Cashier's check or money order for \$144.00 (\$169.00 if accused of speeding in a school zone)
