Dear Resident,

Attached is the Fence Permit Application. Please complete the form with all the required information and necessary documentation and submit to the Village Clerk during normal business hours.

The Village Board of Trustees finds that it is in the best interests of the Village to regulate the height of fences to address the needs of residents for safety, privacy, preservation of water views and property values, without adversely affecting adjacent property owners or the character of the neighborhood. Refer to Village Code 125-10.1 Fences.

Permits are required for all fences. The only exceptions are for deer fencing that is 95% transparent and temporary construction fences where a building has **already been issued**.

Upon submission of the application and \$75 fee, the Building Inspector will review the application and respond within **four** weeks. After installation, the applicant should notify the building inspector who will schedule an inspection site visit. Applicant will need to provide a fence placement affidavit (attached to application) at that time.

Please refer to Village Code 125-10.1 Fences at www.asharoken.com for detailed information on fence heights, setbacks, locations, acceptable materials, and agricultural property exemptions.

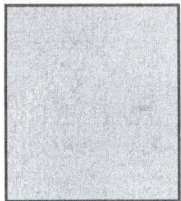
