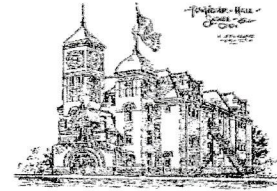

AGREEMENT: I, the undersigned, hereby make application to the Sabina Utilities Department for water/sewer service. I agree to pay for such service at regular published rates and in accordance with rules and regulations, all as approved by The Village of Sabina Council. I agree to use such service for my own purposes and agree not to sell or donate any part of it or permit it to be used for other purposes. I agree that duly authorized agents and employees of said Sabina Utilities Department shall have access to my premises at all reasonable hours for the purpose of installation or removal of meter and inspection of equipment incident to carrying out this agreement. I further agree to hold the Sabina Utilities Department harmless from any claims, real or alleged, for loss or damage to property or persons arising out of the delivery of service beyond the point of metering. I agree to give said Sabina Utilities Department notice when I cease to occupy said premises and I desire service discontinued. In event of its failure on my part to comply with the terms and conditions of this agreement, I agree that said Sabina Utilities Department or its representative may disconnect service hereunder without further notice to me. I also agree that said Sabina Utilities Department or its representative may disconnect service hereunder if this account falls 45 days past due and falls under Ordinance 2003-6 (Ordinance Pertaining to the Enforcement and Collection of Water Bills). Such discontinuance will not constitute waiver of any claims against me for prior service rendered hereunder by said Sabina Utilities Department. I also agree that said utility department reserves the right to send notification to the property owner of any unpaid utility bills.

ATTENTION PROPERTY OWNER: Upon failure of the within named applicant to pay all water and sewer charges incurred at, or upon, the premises above described, I agree upon notice (Pursuant to the Revised Code) to pay the within named Sabina Utility Billing Department for said charges. Such charges not paid within sixty days from the date shall constitute delinquent charges and the Village Auditor shall certify to the County Auditor all unpaid delinquent charges for collection as allowed by law in the same manner as other taxes and assessments.
