No set up in front of a business that uses sidewalk space to promote their business. (I.E. M and Friends, Alice Attic, Full Circle Antiques, and Molto Molto. The best thing to do is ask to confirm.

No set up within 20 feet of an intersection or corner. This is leaving road traffic visible and not blocked by sale tents etc.

Sale space is the sidewalk panel closest to the street and on the sidewalk.

Space is limited to 10 feet wide. Everything is to be secured in case of wind or vehicle wind.

Set up and clean up all in the same day, no overnight staging.

4. Revocation Clause

This permit may be revoked by the Village Board for:

Health code violations

Fire safety violations

Non-payment of fees

Operating outside approved location

Repeated complaints or nuisance conditions

False statements on application
