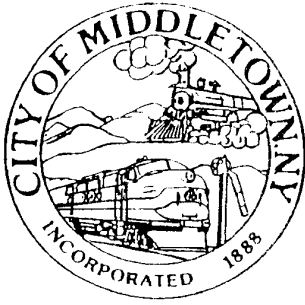

- All questions must be answered truthfully and honestly, according to the best of one's ability.
- The applicant must sign the application before a notary public.
- The Chief of Police and the City Clerk may appoint a designee to act in their stead. The designee(s) must sign and date the application in his/her own name.
- Licenses shall be issued as of April 1 in each and every year and shall expire on the March 31 next succeeding, unless sooner suspended or revoked.
- **The annual license fee is \$500.00.**
- All insurance policies must include a provision which names the City of Middletown as an additional certificate holder and which requires the City to be notified in the event of any changes in such policy, copies of which must be included with this application.
- All vehicles are subject to an annual inspection for the purpose of renewing this yearly license as well as subject to (4) annual inspections of which (2) physical inspections will be made and (2) mechanical inspections will be made.
