

Application for Taxi Company/Vehicle License



The City of Orange Township, New Jersey
Department of Planning & Economic Development
Licensing Division

This form is for use in applying to the City of Orange Township for annual taxi company and vehicle licenses (initial or renewal). This is not an application for a taxi operator license, which is required for all persons who will be operating licensed taxi vehicles. Applications for initial or renewed taxi company and vehicle licenses must include the following documents: (1) New Jersey Business Registration Certificate for the taxi company; (2) Certificate of Good Standing issued by the State of New Jersey, Division of Taxation for the taxi company; (3) proof of general commercial, workers' compensation and automobile liability insurance coverage meeting minimum requirements established under State law; (4) copy of vehicle registration issued by the New Jersey Motor Vehicle Commission for each vehicle; (5) photographs of all 4 exterior sides and the entire interior of each vehicle; and, (6) names and home addresses all stockholders, members or partners holding 1.00% or more ownership interest in the taxi company, as well as names and addresses of all officers, directors or others in like positions, whatever the title.

All applications must also be accompanied by a nonrefundable fee of \$100.00 per taxi vehicle payable to the "City of Orange Township", and a copy of the taxi company owner's current, valid New Jersey Driver License (there is no separate fee for a taxi company license). Each taxi company or vehicle license is valid through the next-subsequent November 14, regardless of application date, and a renewal application must be received on or before November 15 of each year to avoid penalty. Submission of an application to the City does not constitute approval of a license; and, the City reserves the right to accept or reject any application as determined appropriate in accordance with applicable law.

NOTE: Each taxi vehicle must be inspected by the City of Orange Township Police Department, and found to be in sufficiently safe and clean condition for transportation of passengers prior to approval of any license. No more than 6 taxi companies may be licensed by the City at any given time, and each licensed taxi company may be issued a maximum of 6 vehicle licenses.
