 - **Reservations will not be considered confirmed until the above are received by the Village.**
- Cancellations may be made up to **30 days** prior to your reservation for a full refund.
- It is agreed that the park will be left clean and orderly after the rental, resulting in Damage Deposit check being voided.
 - All trash will be picked up and disposed of in the dumpster provided by the Village.
- All pets must be leashed and pet waste picked up and properly disposed.
- **Neglecting any of the above can result in the loss of deposit and denial of future park rentals.**
- It is understood that Village of Pewamo park facilities are unattended facilities and that the Village does not provide supervision, instruction, or assistance for the use of such facilities.
- It is understood that athletic activity involves risk of serious injury. The undersigned represents that he/she is voluntarily using the Village of Pewamo Park facilities with full knowledge of all potential dangers involved therein.
- It is understood that the Village of Pewamo is not responsible for property that is lost, stolen, or damaged while in, on, or about its park facilities.
- The undersigned certifies that he/she is 18 years of age or older.
- The undersigned expressly agrees to indemnify and hold the Village of Pewamo harmless from any demand, claim, judgment, award, legal proceeding or loss of any kind arising from the use of Village park facilities as authorized by this contract.
