- Written narrative describing how proposed facility complies with the Mesa Zoning Ordinance (MZO) including:
 - Store hours
 - No outdoor seating or vending
 - No drive-through window
- Delivery service, if available, complies with AZDHS regulations
- Vicinity Map (note major cross streets)
- Site Plan - Note any parking spaces and building entries
- Floor plan with floor area calculations in square feet showing dispensary area, cultivation area, infusion area, storage areas, and customer waiting area and % of GFA
- Written acknowledgement a security plan has been filed with the State and will operate in compliance with A.R.S. §36-2804(B)(1)(C)
- A table showing compliance with separation requirements of Section 11-31-34 in the Mesa Zoning Ordinance providing addresses with facility names and associated map detailing distances to nearest:
 - Other medical marijuana facilities and identify type
 - Alcohol or drug rehabilitation facility
 - Substance abuse treatment facility
 - Public park
 - School (grades: K-12)
 - Public library
 - Church or place of worship
 - Day care/preschool
 - HOA open space
