Pursuant to Chapter 4-20:

- (A) No Person shall, within the territorial limits and jurisdiction of the Borough deal in, conduct or engage in the business of the sale, purchase or exchange of new, secondhand or used automobiles, trucks/van, buses, recreational vehicles and motorcycles without first having obtained a license from the Borough Clerk.

License fee (218-3) – Each licensee shall pay an annual license fee of **ONE THOUSAND FIVE HUNDRED (\$1,500) DOLLARS** for the general use of the Borough, before issuance of the license – all licenses shall expire on December 31st of the year of issue at 12:00 midnight, local time.
