Applicant hereby agrees that if the applicant or any of the officers, agents, servants or employees of the applicant shall violate any of the provisions of said ordinances, or the Act of the General Assembly of the State of Missouri, under the authority of which said ordinances were adopted, or any other law of the State of Missouri or ordinance of the City of Des Peres Missouri, relating to the regulation, control, sale, manufacture, possession, transportation or distribution of intoxicating liquor, or fails to obtain and at all times have a license from the State Division of Alcohol and Tobacco Control of Missouri, or shall have made or there shall have been made in applicant's behalf a false affidavit in applying for this license, the Board of Aldermen of the City of Des Peres may revoke any permit or license issued upon this application in the manner now or hereafter provided by ordinance. Applicant agrees to comply.

Applicant hereby states that: No permit issued by the City of Des Peres, Missouri, or by the Director of Alcohol and Tobacco Control of the State of Missouri under the Acts of the General Assembly of Missouri has been revoked or suspended.
