TOWN OF DEERFIELD LOCAL LAW #2 OF THE YEAR 2009

A Local Law amending Town of Deerfield Local Law #2 of 1996 regulating transient merchants and peddlers.

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF DEERFIELD,
COUNTY OF ONEIDA, NEW YORK,
AS FOLLOWS:

SECTION I:

Local Law No. 2 of 1996 is hereby amended at the subdivision entitled "(d) License" so as:

- a) To delete therefrom the provision "A fee of ten dollars (\$10.00) for the license shall be paid to the Town at the time said license is issued with renewal required annually from that point forward"; and
- b) To include therein, in its place and stead, the following provision: "A fee for the license shall be paid to the Town at the time said license is issued in an amount as determined by the Town Board from time to time by resolution; license renewal is required annually thereafter."

SECTION 2:

Local Law No. 2 of 1996 is hereby amended so as to include a new subdivision as follows:

(i) Prohibited Acts

1. It shall be unlawful for any person to enter upon private property for the purpose of peddling or soliciting before the hour of 9:00 A.M. of any day or after the hour of 7:00 P.M. of any day except upon the invitation of the householder or occupant.
2. It shall be unlawful for any peddler or solicitor in plying his or her trade to ring the bell or knock upon or enter any building whereon there is painted or otherwise affixed or displayed to public view any sign containing any or all of the following words: "No Peddlers", "No Solicitors", "No Agents", or other wording, the purpose of which purports to prohibit peddling or soliciting on the premises.
3. No peddler or solicitor shall peddle, vend, or sell his or her goods or wares within two hundred (200) feet of any place occupied exclusively as a public or private school or for school purposes, nor shall he or she permit his or her cart, wagon or vehicle to stand on any public highway within said distance of such school property.
4. No peddler or solicitor shall falsely or fraudulently misrepresent the quantity, character or quality of any article offered for sale. No person shall by any trick or device or by any false representation obtain or attempt to obtain admission to the house or garage of any person or corporation in the Town.
5. No peddler or solicitor shall blow a horn, ring a bell or use any other noisy device to attract public attention to his or her wares, or shout or cry out his or her wares.

SECTION III:

This Local Law shall take effect immediately upon filing in the office of the Secretary of State.

RESOLUTION # 83-2009 PEDDLER LAW FEE

BE IT RESOLVED that the Town Board of the Town of Deerfield does hereby append the Town Fee Schedule to include a fee of \$25.00 for a Peddler permit.
