**REQUIRED:**

1. **Sketch(es)** - at a scale of at least ¼ inch equals one foot

- a. showing the sidewalk adjoining the establishment where the sidewalk café/vending is proposed, detailing the location of the curb, any trees and tree wells, mailboxes, street lights, utility poles or other obstructions; and
- b. showing the location of all tables, chairs, benches, and other equipment proposed to be located on the sidewalk.

2. **Insurance**

The applicant must submit, prior to the issuance of the permit, a certificate of general liability insurance naming the applicant and the Village of Irvington, its officers, agents and employees as named insured, with the following limits:

- a. For personal injury \$3,000,000 per individual and \$5,000,000 per occurrence
- b. For property damage \$3,000,000 per individual and \$5,000,000 per occurrence
- c. Effective for the duration of the permit and containing a provision prohibiting its cancellation except upon 20 days' notice to the Village of Irvington.

3. **Indemnification**

I (we) the undersigned Applicant(s) of the above noted business, do hereby agree to indemnify and hold harmless the Village of Irvington, its officers and employees against any loss of liability or damage, including expenses and costs for bodily injury, and for property damage, sustained by any person as a result of the applicant's operation of the sidewalk café/sidewalk vending on public property.

I have read Chapter 184 of the Irvington Village Code and agree to comply with all operating restrictions and conditions contained therein.
