

VILLAGE OF ELBRIDGE
CAR WASH POLICY

It is the Village of Elbridge Board of Trustees' intention to allow local non-profit groups from the Town of Elbridge and Villages of Elbridge and Jordan to conduct car washes at the Elbridge Free Library or Elbridge Firehall as fund-raisers.

1. Any group or organization wishing to conduct a car wash must initially apply at the Elbridge Village Hall each year; subsequent scheduling of car washes during the year may be done verbally by telephone.
2. It will be left to the Elbridge Village Board's discretion as to whether or not a car wash should be cancelled due to a water shortage or for any other unforeseen circumstances.
3. It will be the user's responsibility to take proper care of the facilities and to put things back the way they found them.
4. It will be the user's responsibility to supply their own equipment (i.e., hose, soap, pails, etc.), and to make arrangements for the water to be turned on at the library or firehall.
5. A certificate of insurance will be required to be supplied to the Village of Elbridge by the user group with the Village of Elbridge named insured.
6. Those groups using water at the Elbridge Free Library building will be required to supply Olympus with a certificate of insurance with Olympus named insured.
7. The user shall not permit people under their control and direction to be located within the public right-of-way or so close to any moving traffic so as to constitute a hazard to themselves or to constitute a dangerous distraction or block the visibility of passing motorists.
8. The user shall hold the Village of Elbridge and Olympus harmless from any and all claims, actions, damages, costs, attorney's fees, or threat thereof arising out of the car wash.
