If License is Approved the following apply:

Display of License. Each person granted a license to solicit shall carry the license on his or her person while soliciting and must produce and show the license on demand to any person solicited, police officer, or Borough official. No person issued a license shall alter, remove, deface, or destroy it in any way.

Nontransferable. Each license shall be personal and not assignable or transferable, nor shall any license or card be used by any person other than the licensee or the person for whom the license is issued.

Penalties for Violations. Any person who violates any provision of the Solicitation Ordinance shall be subject to a fine of not less than three hundred (\$300.00) dollars and not more than six hundred (\$600.00) dollars. In default of the payment of a fine, a person who is found to violate this ordinance shall be subject to imprisonment for a term not to exceed fifteen (15) days.

If License is Denied, Suspended or Revoked:

Any person who wishes to appeal a denial, suspension, or revocation of a license, may do so by filing written notice of such appeal within 30 days of notice of the denial, suspension or revocation with the issuing officer and include the reasons for the appeal. The board of supervisors will hear the appeal at their next regularly scheduled meeting following the date of receipt of the appeal. At the appeal hearing, the appellant shall be given the opportunity to present testimony and evidence in support of the reasons for appeal.
