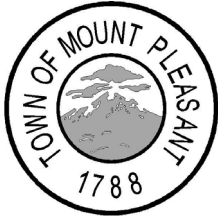

BE ADVISED: A License to Peddle or Solicit from the Town of Mount Pleasant does NOT permit you to peddle or solicit in the Villages of Pleasantville or Sleepy Hollow. You must obtain a license from the Village.

Certification:

I, _____, certify that all statements made in this application are true to the best of my knowledge and belief, that I have read and understand Chapter 153 of the Town Code of the Town of Mount Pleasant under which this application is made. I agree to abide by and conform to all its provisions.

I further acknowledge that I shall not:

- i. Engage in peddling and soliciting before the hour of 9:00 a.m. of any day or after sunset or the hour of 7:00 p.m. of any day, whichever occurs first;
- ii. Enter upon any premises or property, to ring the bell, knock upon, or enter any building whereon there is displayed any sign containing any or all of the following words: "No peddlers, no solicitors, no agents," or other wording;
- iii. Peddle or solicit within 200 feet of any church, place of worship, or school, nor stand my vehicle, cart, or wagon on any public highway within said distance of such school property;
- iv. Solicit any business at the scene of any accident;
- v. Cry out, blow a horn, ring a bell, or use any sound amplifying system;
- vi. Peddle or sell in any congested area when or where such activity may impede, endanger, or inconvenience the public or add to the congestion of such place or area.

NOTICE: Pursuant to the Penal Law, Section 210.45, it is a crime punishable as a misdemeanor to knowingly make a false statement herein.
