Raffle License Applicants:

A Raffle License may be issued to not-for profit or nonprofit organizations (*i.e.* religious, charitable, educational, fraternal, or veteran's organizations) as defined in Chapter 114 Title XI: Business Regulations of the Code of the Village of Mahomet. A copy of the Village ordinance is attached.

Applications are required to be submitted and should be turned in to the Village Clerk for processing at least thirty days before the first day intended for the sale of raffle chances. The Village Clerk shall refer all applications to the Police Department and Village Administrator for review or investigation of the representations in the application. The Clerk shall issue or deny the license within thirty (30) days of application or the license shall be deemed granted.

The following conditions render individual's ineligible to hold a raffle:

- (A) Any person whose felony conviction will impair the person's ability to engage in the licensed position.
- (B) Any person who is or has been a professional gambler or gambling promoter.
- (C) Any person who is not of good moral character.
- (D) Any firm or corporation in which a person defined in (A), (B) or (C) has a proprietary, equitable or credit interest, or in which such a person is active or employed.
- (E) Any organization in which a person defined in (A), (B) or (C) is an officer, director or employee, whether compensated or not.
- (F) Any organization in which a person defined in (A), (B) or (C) is to participate in the management or operation of a raffle as defined in the "Raffles Act".

The manager shall give a fidelity bond in the sum of \$1,000 or such other amount as equal to the aggregate retail value of all prizes given in any single raffle, whichever sum is greater, in favor of the organization conditioned upon the honesty of such manager in the performance of his duties of such manager. Term of the bond shall provide that notice shall be given in writing to the Village Clerk not less than 30 days prior to its cancellation. The Village Board may waive this bond requirement by including a waiver provision in the license issued to an organization.
