To qualify for Deferred Disposition, you must meet the following requirements;

- Must be at least age 17 at time of offense.
 - *Not eligible if under 17 years of age at time of offense.*
- Must have a valid TEXAS driver's license or permit or proof of active military duty.
 - *Not eligible if driver's license is suspended.*
- Do not hold a CDL license.
 - *Not eligible if you hold a **CDL** or held a CDL at the time of offense.*
- Violation was not in a work zone with workers present.
 - *Not eligible if in work zone with workers present*
- The citation was not a result of an accident.
 - *Not eligible if a result of an accident.*
- You were not speeding 25 MPH over the speed limit.
 - *Not eligible if speed is 25 mph over limit.*
- Not currently on Deferred Disposition for a moving violation.
 - *Not eligible if currently on deferred for a moving violation.*
- You must not have illegally passed a school bus loading or unloading.
 - *Not eligible if you passed school bus loading/unloading.*
