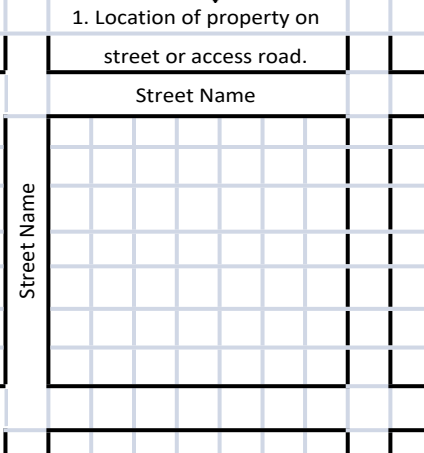
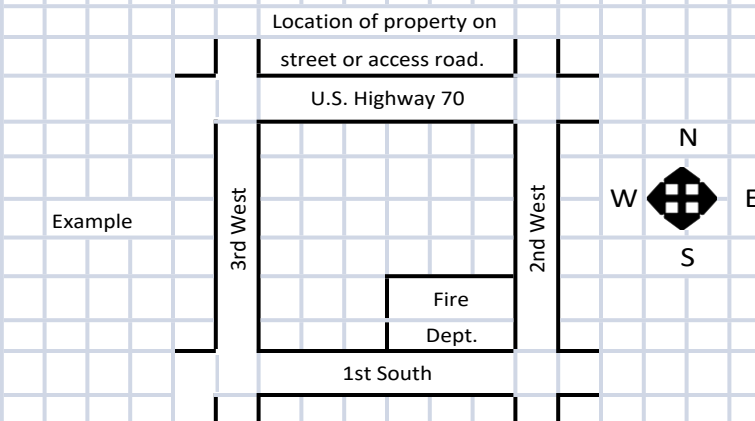

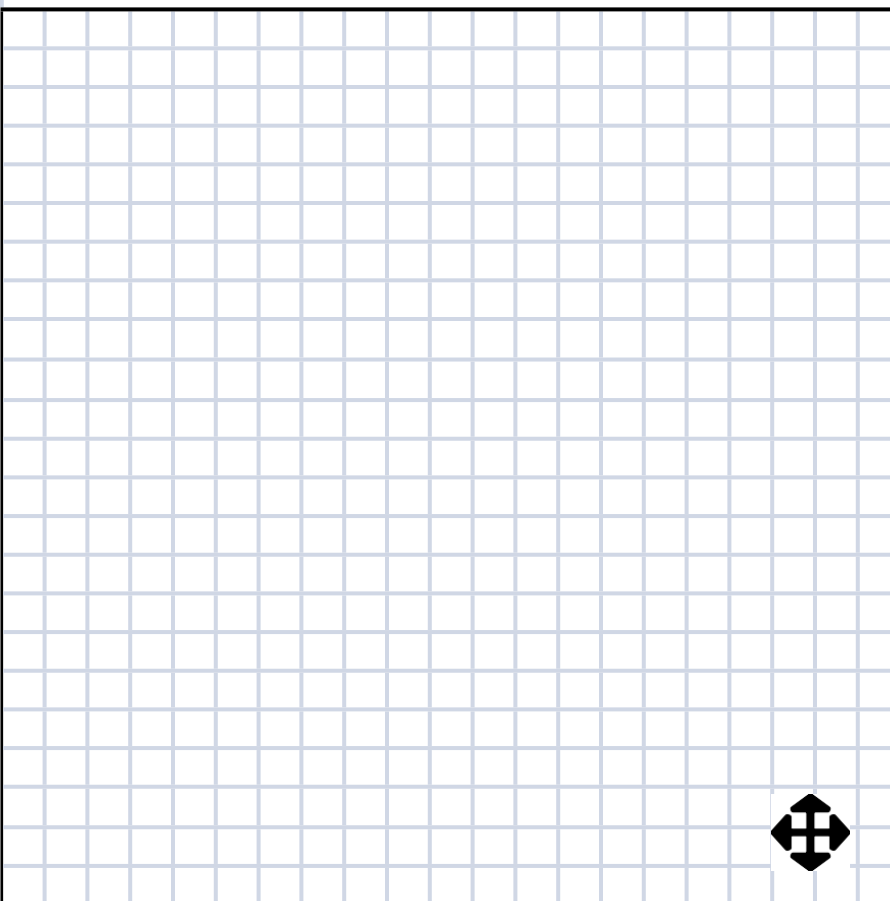

Draw a plot plan and show the following:

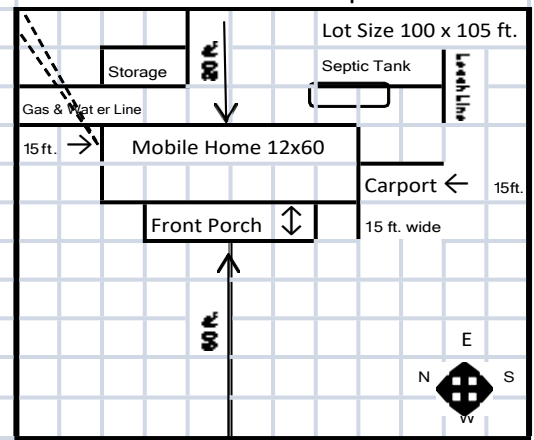
1. Location of property on street or access road.

1. There must be a minimum of 20 feet from the front property line to the closest structure, ie., porch, swing, carport.
2. There must be a minumuf of 10 feet from the side property line to the closest structure.
3. There is no minimum from the back property line, but we recommend 10 feet.
4. EXCEPTION-DOUBLE FRONTAGE (Corner Lot) minumuf of 20 feet from the front and side property lines to the closest structure.
