



Borough of Eatontown Tree Removal /Tree Trimming Application for Permit

Homeowner/Contractor Application

Application Fee \$25

Any of the following living trees having a trunk of a diameter greater than as set forth below, measured at one foot above ground level: **(a)** Deciduous tree: six inches (or circumf. 19 inches). **(b)** Coniferous tree: six inches (or circumf. 19 inches). **(c)** American holly tree (*Ilex opaca*), dogwood (*Cornus florida*), and broadleaf evergreens: one inch shall apply to the Zoning Officer for permit to remove such tree(s).

Trimming of trees located in the front yards of residential properties requires prior review and approval from the Zoning Officer in coordination with the Department of Public Works.

Chapter 307 of the Code of Eatontown titled “Trees, Removal of”

307-1 Purpose:

The governing body of the Borough of Eatontown finds and concludes that trees are a significant, historical, aesthetic, and valuable ecological resource. Because of this, trees on public and private property are to be protected and preserved. Preserving and protecting the Borough’s trees will counteract air pollution, minimize soil erosion and other related environmental damage, enhance the aesthetic environment of the Borough, and preserve property values. This Ordinance is intended to maintain and enhance the general health, safety, and welfare of the residents of the Borough by preserving and protecting one of the Borough’s most valuable assets, its trees. This Ordinance provides that no trees shall be removed, cut down, or otherwise destroyed, unless a Tree Removal Permit has been issued by the Borough. Tree trimming and pruning are exempt from the permitting requirements unless the tree would be destroyed by the trimming or pruning.

24-3 Permit Requirements:

Any residential or commercial property owner seeking to remove a tree on their property is subject to an application process, as defined in 307-3 (a) (b)

VIOLATIONS AND PENALTIES

§307-7 Fines and Penalties.

A. Commercial Properties: All allegations of code violations shall be referred to the Zoning Officer. The Zoning Officer shall determine site plan conformity.

1. In consultation with the Borough Engineer, the Zoning Officer shall have the authority to determine if the property is in violation of Site Plan approval.

2. If the property is in violation of Site Plan approval, the property issue shall be returned to the Planning Board or Zoning Board for resolution.

3. If a violation is found to exist which does not require appearance at the Planning Board or Zoning Board, the matter shall be referred to the Shade Tree Commission, who in conjunction with the Borough Engineer shall recommend replacement trees or payment to the tree fund. Commercial Properties who disagree with this decision may appeal to the Planning or Zoning Board, as appropriate for final resolution.

B. Residential Properties: All residential properties whose owners cut a non- hazardous tree without permission shall be subject to the following penalties.

1. Trees on a public easement or right-of-way: The owner shall meet with the Shade Tree Commission to determine whether a replacement tree must be planted. If a replacement tree is not plausible due to issues with topography and roots, etc. the owner shall be required to make a payment to the tree fund. Failure to do so will result in a violation of the ordinance and the issuance of a summons to Court by the Code Enforcement Officer.

C. The Zoning Officer shall be responsible to implement and enforce this Ordinance. The failure to replace a tree or make a payment to the Eatontown Tree Fund as required by the Ordinance shall result in a penalty to be assessed in an amount up to \$2000 per violation.
