I, the undersigned Defendant, hereby enter my plea of **NO CONTEST**, waive my right to a trial by judge or jury, and request Deferred Disposition. I understand that I may be required to come to Court and/or sign additional documents if my request is granted. I also agree to comply with all the terms required for deferral of the citation. I understand that if I do not comply I will be sent a notice to appear in court to show cause why I did not complete the terms of this deferral.

_____ **(Initials)** I, the undersigned Defendant, affirm I have not had Deferred Disposition in the Alvarado Municipal Court within the preceding twelve (12) months to dismiss a citation.

_____ **(Initials)** I, the undersigned Defendant, affirm that I understand that if I do not submit this document along with proper identification, by mail to 104 W College Ave, Alvarado, Texas 76009, I have not disposed of the above referenced case and will still need to appear in the court no later than my appearance date on my citation to resolve the case.

_____ **(Initials)** I, the undersigned Defendant, affirm that I understand that after receiving approval from the Judge, I will receive a copy of my probation order by email. I understand that I will be placed on probation for a period not to exceed six (6) months and IF I VIOLATE any term of my probation, this citation may not be dismissed and may be reported to the Texas Department of Public Safety as a conviction on my driving or criminal record.

_____ **(Initials)** I, the undersigned Defendant, affirm that I understand that I must pay all assessed costs, fees, and fines associated with Deferred Disposition for the above referenced case within sixty (60) days of submitting this signed request to the court.

Conditions (if applicable):

- ❖ *If you were under 25 years of age at the time of the offense, you must complete a Driving Safety Course as a condition of Deferred Disposition – must be completed during deferral period.*
- ❖ *If you currently hold a Provisional Driver's License, you must complete a driving examination that is conducted by the Texas Department of Public Safety and a Driving Safety Course.*

*You are **NOT** eligible:*

- ❖ *If the above referenced offense is for going 30 miles or more per hour over the posted speed limit or for speeding 95 mph or more.*
- ❖ *If you currently hold or held at the time of the offense a Commercial Driver's License.*
- ❖ *If the offense occurred in a Construction Zone with Workers Present*

If one of the above describes your violation, you will need to request a court date to speak with the Municipal Court Judge.
