DECEASED DOGS MUST BE REPORTED BEFORE OR ON RECEIPT OF RENEWAL FORMS.

INSTRUCTIONS: The owner of record must complete and mail this portion of the license to the municipality in which the dog is harbored within 10 days of the occurrence of any of the following:

1. Loss of Dog - Fill in official ID number. Check the appropriate box for lost or stolen dog and enter the date of loss.
2. Change of address of Owner of Record - Fill in the official ID number. Check the box for change of address and fill in the new address, County and Town/Village/City.
3. Transfer of Ownership:
 - A. (1) Fill in the official ID number; (2) check the transfer of ownership box and enter the date; (3) enter the County of the new owner; (4) enter the Town or City (or licensing Village in Nassau, Westchester, or Rockland Counties) of the new owner; (5) fill in the new owner's name, mailing address, County and Town/Village/City.
 - B. Give the top portion of the license to the new owner along with the steel identification tag.
 - C. The new owner must immediately present license to the Clerk of the Town or City, or in the Counties of Nassau, Westchester and Rockland, incorporated Village in which the dog is to be harbored and make the application for a new owner's license for the dog.
