Application for Amusement License Registration of Amusement Machines

Ordinance 251-1 Annual License Required.

Every owner, lessee, or manager of a permanent place of amusement, in the Borough of Kittanning, shall pay an annual license fee to the Borough, on or before the first day of October in every year:

Where the seating capacity is 100 or less: \$25.00/ yr.

Where the seating capacity is more than 100 but less than 200: \$50.00/ yr.

Where the seating capacity is more than 200 but less than 300: \$75.00/ yr.

Other seating fees are a graduated cost based upon numbers up to more than 600: \$175.00

Total Fee for annual Amusement license:

Article II Licensing of Amusement Devices

251-3 License required for jukeboxes, pinball machines, or any coin-operated (cash, credit) amusement devices.

After the 30th day of June 1948, it shall be unlawful for any person or persons, firms, partnerships, unincorporated associations, or corporation, to operate any jukebox, pinball machine, or coin-operated amusement device, with in the Borough of Kittanning without first obtaining a license for said operation, or permitting said operation, from the Mayor, license period is good for one (1) year.

Jukebox Fee: \$50.00 per machine per year

Pool table (cash operated): \$100.00 year

Pinball machine, or other coin/cash/credit amusement device: \$100.00 per each machine

Number of machines () X \$100.00 per year

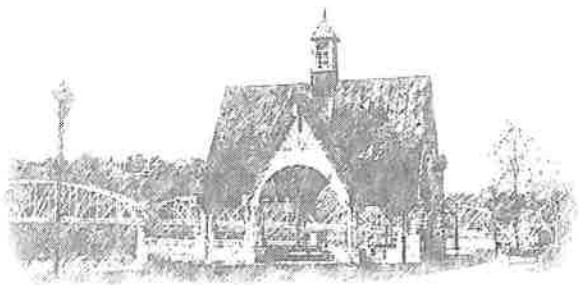
Total fees paid for registration of machines

251-5 Responsibility for payment of license fee.

The aforesaid license fees shall be paid by the owner or proprietor of the business or establishment in which said machines are located.

251-6 Violations and penalties

Any person or persons, firm, partnership, unincorporated association, or corporation, violating any provision of the article shall upon conviction, be sentenced to pay a fine of not less than \$25.00 or more than \$600.00 and costs of prosecution.
