MUST BE OVER 21 YEARS OF AGE TO SIGN THIS FORM.

The undersigned agrees to indemnify, defend and hold the Incorporated Village of Lake Grove harmless from any liability which may arise by reason of any injury or damage to person(s) or property resulting from the use of said Village road for purposes of a block party or from execution of this agreement.

BLOCK PARTY RULES

- ◆ All paperwork must be completed and returned to this office a minimum of two (2) weeks prior to the party date. If paperwork is not filed on time, a permit will not be issued
- ◆ Applications may be submitted up to 4 months prior to the party date. Applications cannot be faxed. Applicant/Permit Signer must be a resident of the street to be closed and must be over 21 years of age.
- ◆ A block can only be closed from one corner to the very next corner. Partial closing of a block is permitted.
- ◆ **The Hold Harmless Clause must be signed by a resident of every house within the area to be closed, including all corner houses.** Everyone signing the Hold Harmless Clause must be over 21 years of age. Every residence having property within the party area must have a signature; it does not matter where the driveway is or which way the house faces. If a signature cannot be obtained from a residence, the party must be moved beyond that property line, but the occupants must have an alternate means of ingress and egress.
- ◆ If a house is vacant, please note the house number on the Hold Harmless Clause and mark it as vacant.
- ◆ All signatures must be on the Hold Harmless Clause form, not on plain paper. Signatures on plain paper will not be accepted.
- ◆ Cones will be provided by the Department of Public Works for closing the road. **YOU MAY NOT, UNDER ANY CIRCUMSTANCES USE ANY SORT OF VEHICLE TO BLOCK THE STREET.** Emergency vehicles must be allowed access at all times. **NO EXCEPTIONS.**
- ◆ **Any person residing on said street must not be denied vehicular access to and from his/her property. NO EXCEPTIONS.**
- ◆ Permits are issued until 10:00 pm only. Everything must be off the street, and the road opened, by 10:00 pm.
- ◆ Clean up of the street after the party is the responsibility of the residents.
- ◆ ***Fireworks*** are illegal in the State of New York and therefore ***prohibited***.
- ◆ All inflatables, DJs and/or bands must be on ***private property, not in the roadway***. The roadway cannot be blocked under any circumstances, for any reason.
- ◆ The Post Office must be notified to make arrangements for mail delivery.

Failure to comply with these rules will result in no further permits being issued for the street.
