APPLICATION FOR PEDDLER / SOLICITOR LICENSE

This application is required under the Village of Bradner Ordinance # 17-72. Applicants must allow **14 business days** after the application is received for the purpose of investigating the applicant. A charge of **\$25.00 (NON-REFUNDABLE)** is required for the purpose of defraying the investigation costs. A photo of the applicant is required and will be taken upon the completion of the application. Each applicant must complete an application prior to operating within the Village of Bradner. The license will expire **six (6) months** after date of issuance.

* Complaints of illegal or aggressive sales tactics reported to the Village of Bradner from residents will be immediately forwarded to the Attorney General Consumer Protection Office and the Bradner Chief of Police and may result in the forfeiture of your permit.
