Applicant acknowledges that the water being purchased is in an untreated condition and that water obtained from a fire hydrant is not designed to provide water for human consumption. Applicant knowingly, completely and freely accepts this risk and agrees to hold the City of North Bonneville harmless from any and all claims attributable to hydrant water purchase, and from any illness or injury which might arise directly or indirectly from the use of such water or the use of the hydrant.



If using the City of North Bonneville's hydrant meter, applicant acknowledges that **this equipment is on loan**. The following instructions must be followed. YOU ARE ASSUMING ALL RISK FOR ANY AND ALL DAMAGE TO YOU, THE CITY'S PROPERTY OR PRIVATE PROPERTY AND BY SIGNING BELOW YOU AGREE TO HOLD THE CITY HARMLESS AGAINST ANY DAMAGE THAT MAY OCCUR BY YOUR USE OF THE METERING DEVICE AND/OR THE HYDRANT, including, without limitation, damage to any city property.

You agree to the following:

- The City of North Bonneville will install and remove the meter.
- Open and close hydrant slowly to prevent water hammer.
- To use only a hydrant wrench to open and close (no pipe wrenches).
- When a hydrant is to be used for an extended period of time, it must be opened all the way to prevent leaking at drain hole.
- Never leave hydrant open when not in use.
- Never leave wrench or hose or meter on hydrant overnight or unattended.
- Never leave caps off hydrant
- When filling a truck or tender, it must have an approved back flow device or Air Gap.
- City to inspect after hydrant use is completed.
- The City of North Bonneville reserves the right to require a NPDES before approving this application
- The City of North Bonneville reserves the right to remove the water meter and revoke permission to use the meter at any time and for any reason

13.04.290 Authorized use of hydrant and hydrant water.

A. City fire hydrants are available for temporary use through a permitting and metering process to accommodate construction, dust abatement, and road maintenance activities, provided the subject meter is not the sole hydrant available to service the immediate area.

B. It is unlawful for any person other than an authorized City employee, authorized volunteer or member of the Fire Department to operate fire hydrants and hose outlets other than as noted above. Persons wishing to access a hydrant shall fill out an application and pay a meter deposit. City staff will review the application for adequacy. City staff shall collect a deposit, connect the meter to the hydrant and provide operating instructions. The costs to repair a damaged fire hydrant shall be the applicant's responsibility. The base fee for hydrant use shall be in accordance with the adopted utility rates, charges and fees schedule.

C. Hydrant use may be withdrawn in the event of an emergency.

D. The City's fire hydrant water use shall be compensated from the City's General Fund by way of an interfund transfer to the water fund. The rate shall be commensurate with City's water consumption fee per hundred cubic feet.
